## <u>ORDER</u>

- 2. 
- **4.** The Principal of the Institution is permitted to collect the tuition fee and the special fee from the students of BOT course for the academic year 2023-24 as shown in above.

- **6.** The Principal of the Institution is directed to collect from the candidates of BOT course for the academic year 2023-24 the approved tuition fee and special fee through online payment/ cheque/DD/RTGS/IMPS only.
